Town Council Meeting – Thursday, June 18, 2020

The June 18, 2020 meeting of the Barnstable Town Council was physically closed to the public to avoid group congregation. The Town provided Zoom and telephone calls for remote communication for those who wanted to participate. Agenda Chaptering is not currently available for this meeting.

Town Council President Paul Hebert began last night's [Town Council Meeting](#) with the reciting of the Pledge of Allegiance and a Moment of Silence. Public Comment was received through Zoom and phone. Town Manager Mark Ells presented his Town Manager Communications for the period June 5-18, 2020:

1. The Town staff continues to provide programs and service while managing this public health and economic recovery effort. We continue to open our facilities with a major milestone of officially opening beaches on June 27, 2020 and included in the beach opening will be Hathaway's Pond. We continue to work with our business community to assist in their efforts to reopen. We are progressing statewide on issues related to an expedited process to allow for outdoor dining and have provided guidance on our Regulatory Services [webpage](#) to business relative to that process. On the ground we have commenced modification of Main Street Hyannis for the summer season as described at your last Town Council meeting. The Town of Barnstable has postponed the Annual 4th of July Fireworks event to tentatively be held on the Saturday (September 5, 2020) of Labor Day Weekend. According to Governor Baker's Reopening Plan, parades can occur during Phase 4 which means all 4th of July parades have all been

canceled. You can find more information about the Reopening Plans [here](#). I will keep you advised as we progress toward the next phase of the Governor's recovery plan.

2. We are proceeding with the tasks in the budget action calendar for FY 2021 as scheduled. We submitted the recommended FY 2021 Operating Budget to the Town Council on May 12, 2020, a first reading of the proposed FY 2021 Operating Budget on May 21, 2020 and commenced the second reading on June 4, 2020. We will continue with the second reading of the operating budget later this evening. 3. The following are comments by Mark Milne, Finance Director, and I summarizing our approach to the fiscal management of FY 2020 and proposed FY 2021 during this emergency situation.
 - a. When confronted with the pandemic, the Town took immediate action to control spending. Following the State of Emergency declared in our Commonwealth we implemented a hiring freeze, began deferring discretionary expenses, reduced the FY21 original operating budget, and reduced capital spending. These were all necessary steps taken in order to generate reserves, and to protect the Town from committing to a potentially unsustainable spending plan.
 - b. As a result of these actions and the historical comprehensive financial leadership directed by the Town Council and implemented by the Town Manager, we have established strong reserve fund levels that allow for budgetary options going forward under these conditions.
 - c. Maintaining the quality of life in our community and providing sound fiscal management is a delicate balance. The FY 2021 proposed operating budget attempts to minimize program and service level reductions while not becoming overly dependent upon the use of reserves to provide municipal programs and services.
 - d. The proposed budget for FY21 is structurally balanced as presented. \$2.9 million of reserves are used to balance the budget and we are projecting to generate \$3 million in reserves at the close of FY20; in part due to the steps taken to reduce spending this year and next.
 - e. Our most vulnerable area in the proposed budget is the amount of local aid the town will receive from the state. Local receipt estimates have already been reduced by \$2.9 million (15%) from the projected FY20 levels, and new growth in property taxes has been reduced by 25%. On a positive note, only 8% of the General Fund budget is provided in the form of local aid from the state. Upon the final passage of the State's FY21 budget, the potential negative impact to Barnstable in local aid reduction is comparably less than most communities. By implementing the budgetary controls in FY 2020 described above and maintaining appropriate reserve levels the town has options and is prepared to respond to the current fiscal situation.
 - f. We still don't understand the full extent of the financial impact of this pandemic and we continue to proceed with caution. Without questions, our community and its municipal government will need to adjust to the fiscal downturn and future economic conditions. The Town of Barnstable is well positioned to manage this economic situation. The Town's reserves have been created for unforeseeable economic conditions. Our fiscal policies and municipal budgeting procedures provide the Town with financial options. The prudent management of use of reserves will allow for the continuation of high priority services and

provide the necessary time to develop and evaluate a well-designed budget with tactical reductions, if and where needed.

4. On June 3, the Department of Public Works attended a hearing with the Board of Health (BOH) requesting that the BOH consider amending BOH regulations by deleting sections 373-1 (A)(2) and 373-3(G) in their entirety, the effect of which would be to eliminate the free disposal of recyclable materials at the landfill. The BOH voted in favor of this amendment. The Department of Public Works has sent a letter to all prior recycling sticker holders to inform them of the change and their options moving forward. I will keep you advised as we progress on this matter.
5. The Town submitted an application for the 2020 Grant Round of the Massachusetts Dredging Program and has been approved for a grant in the amount of \$500,000 for the Dead Neck-Sampson's Island Dredging and Nourishment Project - Phase III.

President Hebert began the meeting by taking a number of items out of order. **Agenda Item 2020-190** Supplemental Appropriation and Transfer Order in the amount of **\$212,700.00** for the Fiscal Year 2020 Airport Enterprise Fund Capital Budget was referred to a Public Hearing on July 16, 2020. Barnstable Municipal Airport Manager Katie Servis presented **Agenda Item 2020-191** Transfer Order in the amount of **\$52,209.00** for the Fiscal Year 2020 Airport Enterprise Fund Capital Budget which was approved. **Agenda Item 2020-192** Order amending the General Ordinances by adding Chapter 190 Short Term Rental Properties and amending Chapter 170 Rental Properties was referred to a Public Hearing on July 16, 2020. **Agenda Item 2020-193** Order amending Chapter 240 Zoning, Article II, Section 7 adding certain provisions pertaining to Short Term Rentals was referred to the Planning Board. The Public Hearing for **Agenda Item 2020-185** Authorizing the Town Manager to execute a Regulatory Agreement between the Town of Barnstable and Airview, LLC was continued to the Town Council Special Meeting on June 25, 2020. **Old Business** began with the continuation of **Agenda Item 2020-146** Appropriation Order in the amount of **\$71,405,234** for the purpose of funding the Town's Fiscal Year 2021 **Barnstable Public Schools Budget** which was presented by Superintendent Meg Mayo-Brown and Assistant Finance Director Gareth Markwell. The budget was approved. Changes to Recycling at the Transfer Station effective July 1, 2020

At their meeting on May 26, 2020, the Barnstable Board of Health voted to modify the Solid Waste regulations to eliminate the provision of free recycling for Barnstable residents. While this was a difficult decision, there was little choice due to circumstances beyond our control. The regulation was enacted years ago when there was a robust market for recyclable materials which enabled the Transfer Station to utilize recyclables as a source of revenue. Unfortunately, during the past four years, due to upheaval in the world-wide market for recyclables, the demand for these materials has effectively dried-up, except for a few specific items. In fact, we must now pay to dispose of the majority of the recyclable material we receive at costs that in some cases exceed the cost of trash disposal. The Transfer Station operates as an Enterprise Account which means that it must generate enough revenue to completely cover all the costs of operating the facility. As a result of the recycling situation, the Enterprise Account has been operating at a deficit, utilizing cash reserves to subsidize the cost of the recycling operation. This is not a sustainable economic model and has forced the Town to cease the practice of offering free recycling to residents that do not purchase a Transfer Station sticker. Residents do have a number of options for disposing of their recyclable material. They can purchase an annual Transfer Station sticker that runs from July 1 - June 30 for \$250.00. There are also two pay-per-visit options for the disposal of trash and/or recyclable material: one is a \$10.00 per visit fee for disposal of two 30-gallon bags of household trash and recyclables and the other is a \$20.00 per visit fee for disposal of up to five 30-gallon bags of household trash and recyclables. Any bag over the five 30-gallon bag limit is \$4.00 per bag. Residents also have the option of utilizing a number of local private trash hauling services to have recyclables collected at their home. We apologize for any inconvenience or hardship that these changes may present.

Town of Barnstable Announces Guidelines for Temporary Outdoor Expansion

In conjunction with the Governor's directives for Phase II, the Town of Barnstable has released guidelines for expansion of outdoor space for dining facilities and retail space. These guidelines will also complement the plans to close one lane of traffic on Main Street as was announced last week. The guidelines allow for a streamlined approach to a multi-departmental approval. Remote meeting reviews will be held with many of the Town's departments and the applicants. Richard Scali, Licensing Director, and Maggie Flynn, Permit Coordinator, are prescreening the applications for appropriateness and coordinating the plan review. Mr. Scali has been given the approval by the Licensing Authority to administratively review and approve the license extension of premises applications with notice to the Licensing Authority and to the Alcohol Beverages Control Commission. The Governor, through the Legislature, has relaxed the laws by allowing local authorities to approve temporary alcohol extensions of premises which will be in effect until November 1, 2020. The Board of Health has also given administrative approval to the Health Director Thomas McKean to review the applications and to allow temporary exemptions to requirements for outdoor dining as appropriate while maintaining public safety. Licensing Director Richard Scali stated, "This was a multi-departmental approach which was developed in cooperation with Licensing, Planning & Development, Inspectional Services, and Asset Management as well as local Fire Districts in record speed. It will allow our restaurants to be open and operating as soon as possible with expansion of existing outside dining or new patios on private or public space or a combination thereof." All restaurants' outside space must adhere to the social distancing seating and walkway guidelines as laid out by the Governor's directives and the Massachusetts Department of Public Health guidelines. Town Manager Mark Ells stated, "Town staff has worked hard to think outside the box and work with civic and town leaders to come up with a plan that will consider the needs of all our businesses. The plan is still subject to adjustments as we move forward. Each business has its own special set of circumstances and space limitations." 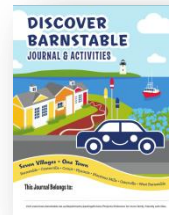

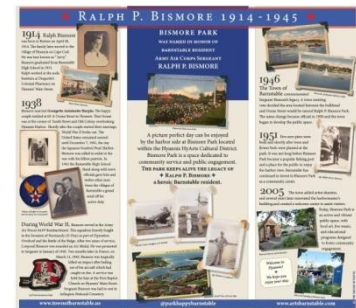

Town of Barnstable Opens Lane on Hyannis Main Street for Pedestrians and Outdoor Business Use

The Town of Barnstable looks forward to safely welcoming residents and visitors to Hyannis Main Street this summer. To provide room for social distancing, and to support the safe and successful reopening of the many small shops and restaurants on Main Street, the Town of Barnstable is making one of the two traffic lanes on the street available to pedestrians and outdoor business use. The southern lane and parking spaces will remain available for vehicle travel and parking. All intersections will remain open for traffic in all directions. The lane closure will begin prior to Barnstable Road and extend to Sea Street and will remain in place through the summer. Work to make this change will begin on Monday, June 15, 2020 is expected to be completed by Friday, June 19, 2020. “The Town of Barnstable is committed to promoting public health and safety and to supporting the small businesses that make Hyannis Main Street unique and vibrant,” Town Manager Mark Ells said. These modifications to the public street are the centerpiece of efforts by the Town of Barnstable and the Hyannis Main Street Business Improvement District aimed at ensuring a successful economic recovery and transition to a safe and prosperous “new normal” in Hyannis. The new temporary outdoor business space will be accompanied

by renewed efforts to enhance lighting and bring public art to the street, as well resumption of customary services including public restrooms and Community Service Officers. “There was much thoughtful discussion and outreach made on this change and we think it will help the downtown thrive this summer. We thank all of the hardworking and insightful partners who are making this happen,” said Elizabeth Wurfbain, Executive Director of the Hyannis Main Street Business Improvement District. 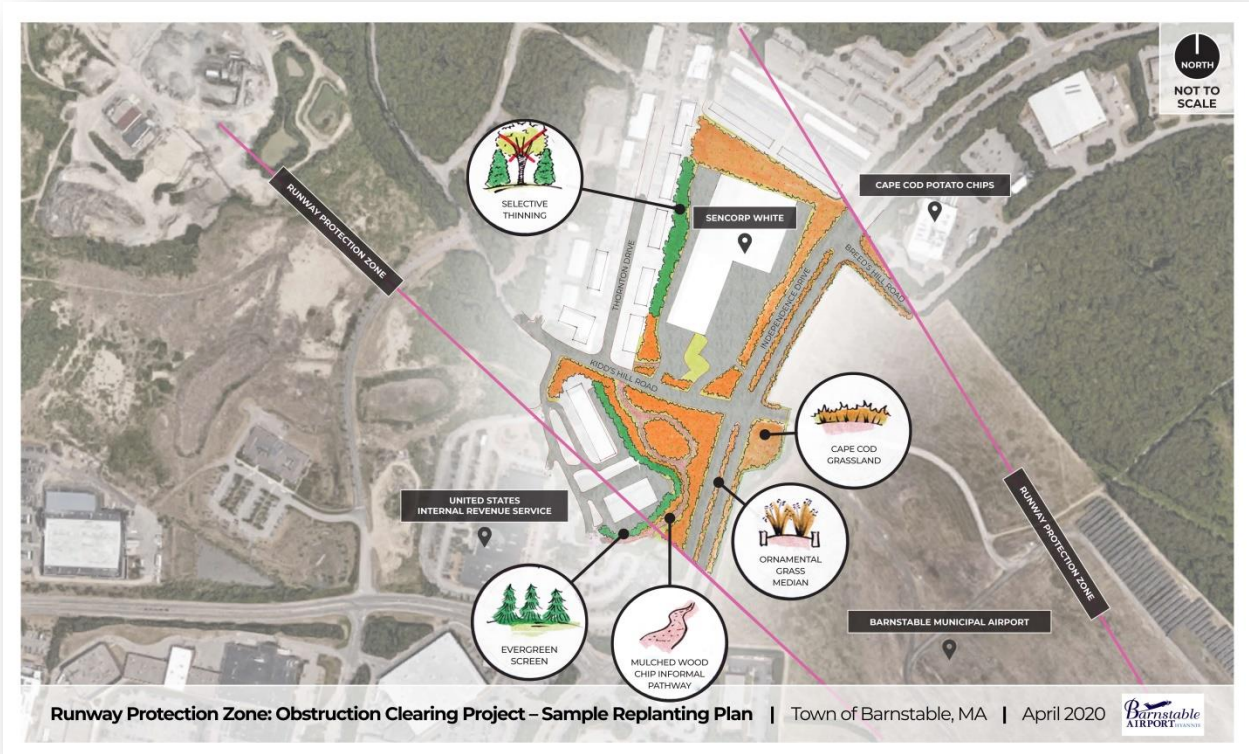
Town of Barnstable Economic Recovery Planning

Barnstable Municipal Airport to Clear Trees Near Runway Approach Areas to Comply with FAA Regulations

Barnstable Municipal Airport (HYA) is in the process of clearing trees impacting the approach surfaces of two runways to meet Federal Aviation Administration (FAA) regulations as well as airport safety and certification requirements. The project support the existing runway approaches and maintain the necessary safety conditions. Tree removal began on May 27, 2020 and will last for four weeks and will be funded by the Massachusetts Department of Transportation (MassDOT). Our initial press release went out on May 11, 2020 outlining the project and identifying post project landscaping to occur. “Safety is always our top priority at the airport, and managing vegetation is an important part of that priority,” said Airport Manager Katie Servis. “As trees and other vegetation grow taller, they create safety hazards for pilots and can limit visibility between the aircraft the runway environment and the control tower. The FAA requires that certain areas of trees and shrubs surrounding airports must be cut. Post tree clearing includes a landscaping plan with native plants and shrubs to replace taller growth that must be removed.” FAA regulations and standards require that airspace Protection Zones (PZs) must be achieved and maintained in order to assure an appropriate level of safety at every airport. PZs are

crucial elements of aviation and public safety because they ensure unobstructed flight paths and views for pilots, air traffic controllers, and ground crew, enabling safe takeoffs, landings, and ground movements. Trees to be cleared include a total of approximately seven acres around Runway 24 (along Willow Street in Yarmouth) and Runway 15 (along Independence Drive in Barnstable). Most trees lie within airport-owned property or property in which the airport has existing easements that allow for tree cutting and maintenance of vegetative growth. The Airport plans for a post-clearing landscaping plan that includes replanting with native grassland species and/or low growing shrubs. This is to commence within the next few weeks. See sample replanting plan below.

ROAD WORK UPDATES

As always please slow down and use extreme caution when traveling through the road construction areas and follow posted safety and detour signs.

***CONTINUES* National Grid Service Road** Construction Work began on November 12, 2019; National Grid will be installing a new gas main on Service Road in Sandwich and Barnstable. Work will be performed during the day, Monday



through Friday from 6:00 AM to 6:00 PM. Service Road will remain open with one-lane of traffic. Work will continue through June 30, 2020. The project is scheduled to be completed in November, 2020.

***CONTINUES* MassDOT Schedules Intersection Improvements at Falmouth**

Road (Route 28) at Osterville West Barnstable Road Construction operations began on September 5, 2019, and will continue through to April 2021 MassDOT has commenced work on the intersection at Falmouth Road (Route 28) at Osterville West Barnstable Road. The road has been redesigned to include exclusive left turn lanes and improve bicycle and pedestrian accommodation as part of the proposed safety improvement work. The work to be done consists of furnishing and installing of new traffic signal equipment at the intersection including emergency vehicle pre-emption system, bicycle and vehicles loop detectors, construction of ADA compliant wheelchair ramps, sidewalks, and driveways, box widening, pavement milling and resurfacing, new pavement markings and signs, drainage improvements, water distribution modifications, existing utility pole relocations, installation of granite curbing, loam and seeding. Work will be performed during the day, Monday through Friday 7:00 AM-3:30 PM. Traffic control will include all required signage, channeling devices for lane shifts and alternating one-way traffic as required. Police details/ flaggers will be on duty. Visit www.mass511.com, a website which provides real-time traffic and incident advisory information, and allows users to subscribe to text and email alerts for traffic conditions. Follow MassDOT on Twitter @MassDOT to receive regular updates on road and traffic conditions. Download MassDOT's GoTime mobile app and view real-time traffic conditions before setting out on the road.

***UPDATED* Pipe Installation, Hinckley Road from Falmouth Road to Route 132**

National Grid Work has started installation of a new gas main in Hinckley Road in Hyannis. The project includes installation of new 10" gas main from Falmouth Road to a regulator pit within Hinckley Road and a 12" gas main from the regulator pit to a tie-in in Route 132. Work will be performed during the day, Monday through Friday from 7:00 AM to 4:30 PM. Work will continue in Hinckley Road through June 30, 2020, and the Contactor will then demobilize until the fall.

***UPDATED* Ongoing Drainage Improvements** Drainage improvements are complete on Eel River Road and work will shift to 357 Bumps River Rd in Osterville. The work includes installation of new drainage structures and castings, adjustment of existing drainage structure castings, pavement repairs and restoration of disturbed areas. Normal work hours will be between 7:00 AM to 5:00 PM, Monday through Friday. Crews will attempt to maintain through traffic during the construction. Lane closures and detours will be supported with police details to direct traffic. Motorists are advised to seek alternate routes to avoid the construction work.

***CONTINUES* Chipseal Pavement Improvements on Various Town Roads**

A chipseal wear surface will be applied on top of the existing pavement on the following roads:

Barnstable Village: Dromoland Lane, Iris Lane, Oakmont Drive, Pine Avenue

Centerville: Clifton Lane, Harvard Street, Pinecrest Road, Sachem Avenue

Hyannis: Bacon Avenue, Chase Street, Dartmouth Street, Murphy Road, Tucker Road

The chipseal process includes street sweeping, installation of a thin asphalt leveling course on an as-needed basis, cracksealing, spraying of a rubberized membrane onto the road surface followed by installation of crushed pea-stone aggregate that is rolled into the rubber membrane material.

Work began on June 2, 2020 and is expected to be complete by June 26, 2020. Normal work hours will be between 7:00 AM to 5:00 PM, Monday through Friday. Through traffic will be maintained throughout the process with support from police details.

***CONTINUES* Roadway Improvements on Portions of Main Street (Route 6A)**

and Mill Way in Barnstable Village Construction is scheduled to continue through mid-June 2020, then finish up in the fall. Normal work hours are 6:30 AM to 4:30 PM, Monday through Friday. Remaining work includes utility line transfers and pole removals in a few locations (by utility companies); paving and marking the roads; finishing sidewalks in several locations; installing site furnishings; installing street lights; refurbishing traffic signals; and other associated work. During active construction there will be lane closures or temporary detours with signs and police details or flaggers to direct traffic past or around the work zones.

***CONTINUES* Roadway Improvements on Portions of Sea Street, South Street,**

and Ocean Avenue in Hyannis Construction is scheduled to continue through the end of July 2020. Normal work hours are 7:00 AM to 3:30 PM, Monday through Friday. Remaining work includes utility line transfers and pole removals (by utility companies); sidewalk reconstruction; paving and marking the roads; installing street lights; and other associated work. During active construction there will be lane closures or temporary detours with signs and police details or flaggers to direct traffic past or around the work zones.

***CONTINUES* Sewer Installation on Portions of Kidd's Hill Road, Merchants**

Way, and Business Lane in Barnstable Village Construction is scheduled to end in July 2020. Normal work hours are 7:00 AM to 3:30 PM, Monday through Friday. Work will involve excavating trenches in the roads, installing sanitary sewer pipes and manholes, backfilling, compacting, and paving. During portions of May and June 2020, Kidd's Hill Road will be closed for construction about 500 feet each side of its intersection with Merchants Way. During portions of June and July, Business Lane and the south half of Merchants Way will be closed for construction.

***CONTINUES* Sidewalk, Traffic Signal, Water Distribution, and Associated Improvements on Independence Drive in Hyannis and Barnstable Village, and on Portions of Mary Dunn Road, Kidd's Hill Road, and Attucks Lane in Barnstable**

Village Construction is scheduled to continue through the end of June, then start up again in September and end in May 2021. Normal work hours are 7:00 AM to 3:30 PM, Monday through Friday. Work will include a new sidewalk and additional drainage systems the full length of Independence Drive, on Mary Dunn Road a short distance south of Independence Drive, on Kidd's Hill Road from Independence Drive to Merchants Way, and on Attucks Lane from Independence Drive to Wilkens Lane. The work will also include a new traffic signal system at the intersection of Attucks Lane & Wilkens Lane; a watermain extension on portions of Attucks Lane and Independence Drive; and additional street lights on portions of Independence Drive and Kidd's Hill Road. During active construction there will be lane closures with signs, cones/construction barrels, and police details or flaggers if necessary to direct traffic past the work zones.

Appointments will not be made with any person experiencing cough, fever, or shortness of breath; anyone tested positive for COVID-19; anyone who has been exposed to a tested positive COVID-19 case; or anyone directed to self-quarantine. Staff will ask you to confirm you do not meet any of these criteria upon making the appointment and upon arrival at the appointment.
