Town Council Meeting – Thursday, October 15, 2020

The October 15, 2020 Meeting of the Barnstable Town Council was physically closed to the public to avoid group congregation. The Town provided Zoom and telephone calls for remote communication for those who wanted to participate. Agenda Chaptering is not currently available for this meeting.

Town Council President Paul Hebert began last night's [Town Council Meeting](#) with Town Councilor Paul Neary leading the reciting of the Pledge of Allegiance. President Hebert offered A Moment of Silence in honor of late Town Council President James H. Crocker, Jr. Public Comment was received by Zoom and telephone. Town Manager Mark Ells presented his Town Manager Communications as a document to the Town Council for the period October 1-15, 2020:

1. We continue to monitor FY 2021 revenues and expenses and develop revenue projections for FY 2022. We are maintaining the strict controls in our efforts to respond appropriately as we progress through FY 2021 and prepare proposed Capital and Operating Budgets for FY 2022. We issued our FY 2022 Budget Instruction to staff on October 7, 2020. There is a Special Town Council Meeting scheduled for October 29, 2020 focused on fiscal policy relevant to the implementation of the Town of Barnstable Comprehensive Wastewater Management Plan. For information on our fiscal year budgets please view the Town's Open Budget website at <http://budget.townofbarnstable.us>.
2. As a reminder the Town of Barnstable continues to follow the Orders and Directives of our Governor. We have moved into Phase 3 Step 2 of the Governor's four phase recovery plan. We are required to adhere to proper social distancing and, if we cannot, to wear face covering. The Governor has frequently updated his Orders and Directives therefore I encourage everyone to go to the Mass.gov COVID website or the Town of Barnstable website and read these Orders and Directives. Thank you for your continued adherence to these requirements.
3. This is a restatement of an earlier communication and is for individuals who have been unable to pay your rent or mortgage due to a loss of income related to the coronavirus. You may be eligible for Emergency Rental or Mortgage Assistance Payments through the [Workforce Housing Relief Fund](#) administered by the Housing Assistance Corporation. The application and additional information about the Fund are available on the Housing Assistance Corporation's website. <https://haconcapecod.org/programs/homeless-prevention/>
4. The Town Council appointed the Town Manager as its representative on the Cape Cod & Islands Water Protection Fund Board (CC&IWPB). The full Board met of October 7, 2020 and adopted regulation for distribution of CC&IWPB Funds. The website for the Board has been created by the Cape Cod Commission staff and the link to the current webpage is: <https://www.capecodcommission.org/our-work/cape-cod-and-islands-water-protection-fund>. Meeting materials or resources can be accessed by clicking on "view all resources" at the bottom of the page and sort by the type of material. I will keep you advised on the progress of this Board.

5. Effective October 19, the bottle redemption center at the Solid Waste Transfer Station, that assists nonprofit groups in our community, will re-open. Participants will be required to comply with CDC-recommended health protocols for their protection as well as the protection of customers.
6. In partnership with the Barnstable Public Schools, the Town of Barnstable, through its Recreation Department, will operate a Remote Learning Center at the Hyannis Youth and Community Center (HYCC), 141 Bassett Lane, Hyannis, MA 02601. Thanks to the generous funding provided by the U.S. Department of Housing and Urban Development through the Town of Barnstable Community Block Grant this program is now FREE. The Remote Learning Center will be used as a safe and structured environment where students from Barnstable Intermediate School (BIS) can come to enjoy supervised remote learning alongside their peers. During remote learning times, the program will strictly follow the BIS schedule for the day. During non-learning periods enrichment activities, including art, games, reading, team building and ice breakers will be played to reinforce important social interactions within the group. As of yesterday we had 6 students enrolled in the Remote Learning Program. We are hopeful that the numbers will continue to increase now that there is no cost to attend the program. We will keep you advised on our progress.
7. Please be advised that effective October 16, 2020 at 6:00 AM data gathering for the Census will cease.
8. The Town received overwhelmingly positive feedback from businesses on Hyannis Main Street this summer in response to the modifications made to the street to create additional outdoor business and pedestrian space and promote public health and safety. In preparation for the winter, the last day of outdoor business use will be Sunday, November, 15th, with barriers to be removed later in the week. The Town continues to work to support businesses on Main Street and throughout the community during these difficult circumstances.
9. Dan Santos, Director of Public Works, provided an update to the Comprehensive Wastewater Management Plan.

OLD BUSINESS began with a Public Hearing for **Agenda Item 2020-193** Order amending Chapter 240 Zoning, Article II, Section 7 adding certain provisions pertaining to Short Term Rentals. Following Town Council discussion, the Public Hearing was continued to the November 5, 2020 Town Council Meeting. Assistant Town Attorney Charles McLaughlin presented **Agenda Item 2021-020** Resolve to petition Barnstable County to discontinue its interest in Craigville Beach Road **was approved.** **Agenda Item 2021-021** Resolve that the Town petition Barnstable County to grant an easement within the full length of Craigville Beach Road in accordance with a sketch attached hereto for all purposes for which public ways are utilized in the Town of Barnstable was withdrawn. Attorney McLaughlin presented **Agenda Item 2021-022** Order to grant to Vineyard Wind LLC an easement from Covell's Beach to Independence Park for utility purposes only which was approved. **NEW BUSINESS** began with referring **Agenda Item 2021-023** Appropriation and Transfer Order in the amount of **\$320,000** Community Preservation Open Space/Recreation Funds for the acquisition of the Open Space Resource consisting of 15.96 acres located at 28 Falcon Road, West Barnstable, Map 195, Parcel 038 and **Agenda Item 2021-024** Appropriation and Transfer Order in the amount of **\$500,000** of Community Preservation Open Space/Recreation Funds for the acquisition of the Open Space Resource consisting of 15.74 acres located at 830 Wakeby Road, Marstons Mills, Map 013 as Parcel 003 to Public Hearings on November 19, 2020. **Agenda Item 2021-025** Confirming reappointments to the Affordable Housing/Growth & Development Trust Fund Board was approved. The Town Council accepted **Agenda Item 2021-026** Acceptance of an Fiscal Year 2021 grant in the amount of **\$4,366.51** from the Commonwealth of Massachusetts Department of Public Health Bureau of Infectious Disease and Laboratory Sciences

Immunization Division for the purpose of supporting influenza vaccine activities for the coming influenza season and **Agenda Item 2021-027** Acceptance of a Fiscal Year 2021 grant in the amount of **\$1,076.50** from the Commonwealth of Massachusetts through its Cities Complete Count Grant Program for the purpose of ensuring a complete and accurate count in the 2020 United States Census. ***The next regularly scheduled Town Council Meeting will be held on Thursday, November 5, 2020 at 7:00 PM. There will be a special Town Council Meeting on Thursday, October 29, 2020 at 7:00 PM. This meeting will be focused on fiscal policy relevant to the implementation of the Town of Barnstable Comprehensive Wastewater Management Plan. At this time, we do not know if the October 29, 2020 meeting of the Barnstable Town Council shall be physically closed to the public to avoid group congregation. Notice of Substantial Amendment to add Cares Act funds to Community Development Block Grant (CDBG) program

Public Review and Comment Period. The Town of Barnstable Planning and Development Department is accepting comments on substantial amendment to the Community Development Block Grant (CDBG) 2019 Action Plan.

The purpose of the amendment is to submit an application to HUD for **\$513,935** in CDBG-CV3 Cares Act funding. This is in addition to the \$168,324 of CDBG-CV Cares Act funds received in July 2020. We are seeking input from residents of Barnstable on the use of the additional \$513,593.

Complying with the flexibilities provided under the Coronavirus Aid, Relief and Economic Securities (CARES) Act the Town will accept comments for a period of not less than 5 days from this notice.

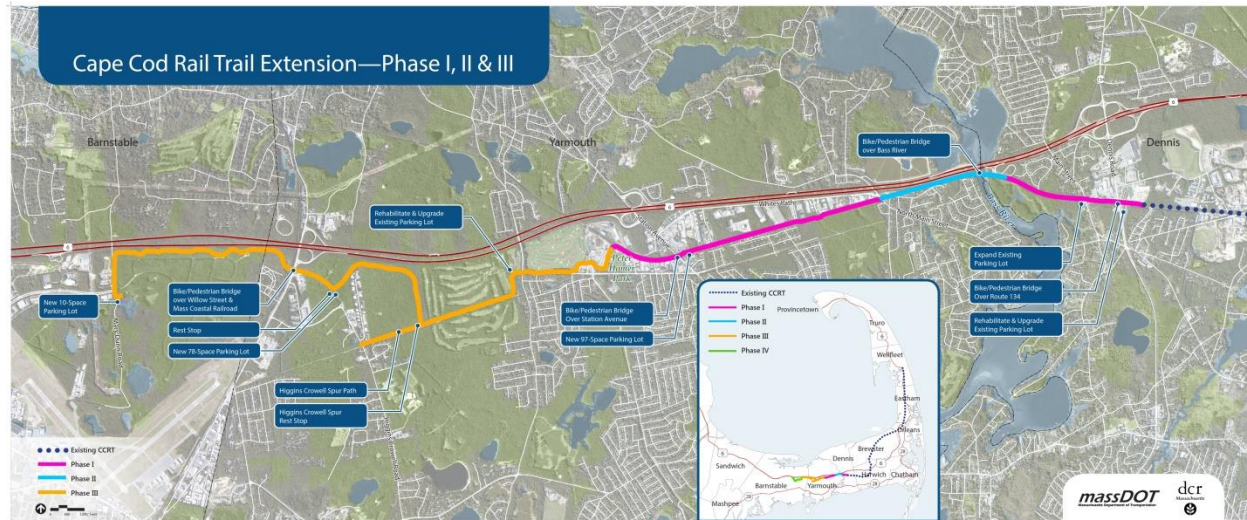

A Virtual Design Public Hearing will be published on the MassDOT website below to present the design for the proposed Barnstable – Yarmouth Cape Cod Rail Trail (Phase III) project in Barnstable and Yarmouth, MA.

PURPOSE: The purpose of this hearing is to provide the public with the opportunity to become fully acquainted with the proposed Barnstable – Yarmouth Cape Cod Rail Trail (Phase III) project. All views and comments submitted in response to the hearing will be reviewed and considered to the maximum extent possible.

PROPOSAL: This project proposes to extend the CCRT through Yarmouth and into a portion of Barnstable, to a new trail head on Mary Dunn Road in the Town of Barnstable. The route of the CCRT Phase III will follow a combination of an existing shared-use path and a newly constructed shared-use path. Bicycle accommodations consisting of a 10' bicycle lane have been provided in accordance with applicable design guides. A secure right-of-way is necessary for this project. MassDOT's policy concerning land acquisitions will be presented in the hearing.

Overview of Barnstable - Design Public Hearing webinar and comment period

A Virtual Design Public Hearing consisting of a pre-recorded video presentation will be published on the MassDOT website below to present the design for the proposed Bearse's Way Shared Use Path project in Barnstable, MA.

Purpose: The purpose of this hearing is to provide the public with the opportunity to become fully acquainted with the proposed Barnstable – Bearse's Way Shared Use Path project. All views and

Proposal: This project proposes to construct a shared use path along the west side of Bearer's Way from the intersection of Bearer's Way at Route 28 to the intersection of Bearer's Way at Pitcher's Way in the Town of Barnstable. The shared use path will accommodate pedestrian, bicycle, and other non-motorized transportation/recreation. The project will include associated utility improvements along the path and roadway. The Town of Barnstable is responsible for acquiring all needed rights in private or public lands. MassDOT's policy concerning land acquisitions will be presented in the hearing.

Barnstable Municipal Airport Seeks Community Input on Development of 20-Year Master Plan

Barnstable Municipal Airport (HYA) has embarked on the development of a 20-year master plan to ensure that the facility can continue to safely and efficiently meet the aviation needs of the National Airspace System and the surrounding community. The preparation of an airport master plan is required by the Federal Aviation Administration (FAA) in order to plan for the future and highlight airport projects in need of future federal funding, including rehabilitation of existing infrastructure. The master plan will not only consider the needs of aviation (the airfield, local general aviation, corporate aviation, and commercial aviation) over the next 20-years but will also consider the needs of Cape Cod and the local region and economy. The plan will also make recommendations for promoting compatible land use around the airport and maximize opportunities for non-aeronautical revenues to help support the airport's financial future. As a publicly funded project at a publicly owned, public use airport, transparency and public engagement is of the utmost importance. To accomplish this, airport

management, along with McFarland Johnson, the consultant hired to conduct the master plan has crafted a public engagement plan that includes outreach to not only airport stakeholders, but the general public as well. A project stakeholder group comprised of over 40 representatives of airport tenants, users, Town of Barnstable officials, businesses, chambers of commerce, the Cape Cod Commission, and more will meet four times over the course of the project to provide feedback and insight for the airport and consulting team as the project is developed. The first of four meetings was held in person, with the second being conducted virtually. The remaining two meetings will be held in person, if possible, otherwise they will be held virtually as well. Traditionally, airport master plans will hold public workshops in the form of an open house once or twice during the course of the project. These workshops act as forums for members of the general public to learn about the airport, the master plan, and proposed improvements and provide feedback in the form of comments to the project team. With the ongoing Covid-19 precautions and because the airport and project team anticipate a high degree of interest from the surrounding community and in the interest of public safety, the content for the first public workshop has been placed online. The airport's YouTube channel (<http://bit.ly/HYAMasterplan>) now features presentations from previous project stakeholder meetings, divided by topic area into short, narrated videos for the public to watch and share. In addition, a dedicated e-mail address HYAMasterPlan@mjinc.com has been set up to receive any questions or comments that the public may have regarding the master plan for the airport. Airport Master Plan documents can also be viewed and downloaded via the airport website (<https://www.town.barnstable.ma.us/airport/>). Comments and questions received by November 2, 2020, will be included in a response to comments and question/answer video that will be added to the channel at a later date. Tips for a Safe and Healthy Halloween During COVID-19

Residents and communities should follow safe and healthy tips to participate in Halloween activities that may limit the risk of exposure to COVID-19. As a reminder, any Halloween activities are subject to the current state [gathering size limits](#) as well as applicable [sector-specific workplace safety standards](#).

Consistent with the [Halloween activity guidance released by the Centers for Disease Control and Prevention](#), some things to keep in mind in celebrating Halloween this year include:

- Enjoy Halloween **outside** rather than attending indoor events.
- Place candy on a platter instead of a bowl
- Instead of traditional trick or treating, opt for one-way trick-or-treating, with treats placed outside of the home for trick-or-treaters as a "grab and go" while keeping distance from others.
- Consider leaving hand sanitizer by any treats left out for trick-or-treaters to use.
- Wear a face mask or face covering. For more information on face masks and face coverings, please see the state's [Mask Up MA](#) webpage.
 - A costume mask is not a substitute for a face mask or face covering. To protect yourself and others, ensure you are wearing a protective face mask or covering instead of or in addition to a costume mask.

- Observe good hand hygiene, including hand washing and use of alcohol-based sanitizers with at least 60% alcohol. Carry hand sanitizer and use it often, especially after coming into contact with frequently touched surfaces and before eating candy.
- Refrain from touching your face.
- Decorate your yard for others to enjoy from their car or while on a socially-distanced walk.
- Hold virtual costume contests or pumpkin carving events.
- Celebrate with members of your household with a Halloween-themed meal, Halloween movie night, or by preparing a Halloween scavenger hunt.
- Maintain social distancing of at least 6 feet of physical distance from all other participants who are not members of the same household.
- Avoid:
 - Attending crowded costume parties held indoors, or any gatherings that exceed indoor or outdoor gathering limits;
 - Going to an indoor haunted house where people may be crowded together and screaming; and

 - Indoor haunted houses; and
 - Hayrides or tractor rides with people who are not in your household.
 - Stay home and refrain from Halloween activities, including handing out Halloween treats, if:
 - you feel unwell;
 - you have tested positive for COVID-19;
 - you have been exposed to someone with COVID-19; or

vaccine for Seniors. This year, we offer the quadrivalent flu vaccine. The quadrivalent influenza (flu) vaccine is designed to protect against four different flu viruses, including two influenza A viruses and two influenza B viruses. For many years, flu vaccines were designed to protect against three different flu viruses (trivalent vaccines). Trivalent vaccines protect against an influenza A(H1N1) virus, an influenza A(H3N2) virus and one influenza B virus, even though there are two different lineages of B viruses that both circulate during most seasons. Adding another B virus to the vaccine aims to give broader protection against circulating flu viruses. We are looking at ways the Town can support our local businesses, while promoting public health and safety. The survey is being conducted to better understand the current and anticipated economic impacts of COVID-19. Data collected through this survey will be used to support economic recovery now and in the coming weeks and months, and can be leveraged by businesses, towns, and other organizations in future grant applications and reports.

ROAD WORK UPDATES

As always please slow down and use extreme caution when traveling through the road construction areas and follow posted safety and detour signs.

***NEW* National Grid New Customer Hookups** Wednesday, October 21, 2020 Neuco crews will install gas service on Bayview Circle, Osterville. Typical natural gas service installation includes marking out underground utilities within the project area, excavation of the street, laying gas main, relaying customer's individual gas service and connecting those services to the main and installing meters. This project should take about five days to complete. Visit ngrid.com/service line to view a YouTube video explaining the replacement of the service pipe to customer homes. Operations will start promptly at 7:00 AM and run until 3:00 PM. Reduce speed, and use caution. All scheduled work is dependent on weather and/or may be impacted due to an emergency situation.

***NEW* Bumps River Bridge Repairs on South Main Street in Centerville/Main Street in Osterville** Construction is scheduled to start in October 2020 and to end in May 2021. Normal work hours are 7:00 AM to 3:30 PM, Monday through Friday, except work under the bridge may also occur during nights and weekends. Work will include repairing bridge piles and cross bracing, as well as repairing and re-surfacing the bridge deck. During active construction there may be lane closures with signs, cones/construction barrels, and police details or flaggers if necessary to direct traffic past the work zone.

***CONTINUES* Drainage & Pavement Improvements on Huckins Neck Road in Centerville/Barnstable Village** Pavement improvements on Huckins Neck Road in Centerville and Barnstable Village will continue through November 20, 2020. The work includes installation of new drainage systems, repairs to existing drainage systems, milling of the existing pavement, and adjustment of drainage structure castings, overlay with new pavement and restoration of any areas disturbed during construction. Normal work hours will be between 7:00 AM to 5:00 PM, Monday through Friday. Through traffic will be maintained throughout construction. Any lane closures will be supported with police details to direct traffic. Motorists are advised to seek alternate routes to avoid the construction work.

***CONTINUES* National Grid Service Road** National Grid will be installing a new gas main on Service Road in Barnstable. Work will be performed during the day, Monday through Friday from 6:00

AM to 6:00 PM. Service Road will remain open with one-lane of traffic. Police details/ flaggers will be used as needed. Gas Line installation is anticipated to be complete in October, with testing being completed through November 2020. Final re-paving of Service Road is anticipated to be completed in spring 2021.

***CONTINUES* MassDOT Schedules Intersection Improvements at Falmouth Road (Route 28) at Osterville West Barnstable Road**

MassDOT Construction operations on the intersection at Falmouth Road (Route 28) at Osterville West Barnstable Road will continue through to April 2021. The road has been redesigned to include exclusive left turn lanes and improve bicycle and pedestrian accommodation as part of the proposed safety improvement work. The work to be done consists of furnishing and installing of new traffic signal equipment at the intersection including emergency vehicle pre-emption system, bicycle and vehicles loop detectors, construction of ADA compliant wheelchair ramps, sidewalks, and driveways, box widening, pavement milling and resurfacing, new pavement markings and signs, drainage improvements, water distribution modifications, existing utility pole relocations, installation of granite curbing, loam and seeding. Work will be performed during the day, Monday through Friday 7:00 AM-3:30 PM. Traffic control will include all required signage, channeling devices for lane shifts and alternating one-way traffic as required. Police details/ flaggers will be used as needed. Visit www.mass511.com, a website which provides real-time traffic and incident advisory information, and allows users to subscribe to text and email alerts for traffic conditions. Follow MassDOT on Twitter @MassDOT to receive regular updates on road and traffic conditions. Download MassDOT's GoTime mobile app and view real-time traffic conditions before setting out on the road.

***UPDATED* Sewer Installation on Portions of Kidd's Hill Road, Merchants Way, and Business Lane in Barnstable Village**

Construction is expected to end in October 2020. Normal work hours are 7:00 AM to 3:30 PM, Monday through Friday. Remaining work includes applying centerline and edge lines on Kidd's Hill Road where recently resurfaced, from Wilkens Lane to a point about 400 feet north of Merchants Way. During active construction there may be lane closures with signs, cones/construction barrels, and police details or flaggers if necessary to direct traffic past the work zones.

***CONTINUES* Sidewalk, Traffic Signal, Water Distribution, and Associated Improvements on Independence Drive in Hyannis and Barnstable Village, and on Portions of Mary Dunn Road, Kidd's Hill Road, and Attucks Lane in Barnstable Village**

Construction is scheduled to end in May 2021. Normal work hours are 7:00 AM to 3:30 PM, Monday through Friday. Work will include a new sidewalk and additional drainage systems the full length of Independence Drive, on Mary Dunn Road a short distance south of Independence Drive, on Kidd's Hill Road from Independence Drive to Merchants Way, and on Attucks Lane from Independence Drive to Wilkens Lane. The work will also include a new traffic signal system at the intersection of Attucks Lane & Wilkens Lane; a watermain extension on portions of Attucks Lane and Independence Drive; and additional street lights on portions of Independence Drive and Kidd's Hill Road. During active construction there will be lane closures with signs, cones/construction barrels, and police details or flaggers if necessary to direct traffic past the work zones.

***CONTINUES* Roadway Improvements on Portions of Main Street (Route 6A) and Mill Way in Barnstable Village**

Construction is scheduled to continue through the fall. Normal work hours are 7:00 AM to 3:30 PM, Monday through Friday. Remaining work includes utility line transfers and pole removals in a few locations (by utility companies); constructing a sidewalk from Main Street to the County Complex parking lot east end; installing street lights; refurbishing traffic

signals; and other associated work. During active construction there will be lane closures or temporary detours with signs and police details or flaggers to direct traffic past or around the work zones.

***CONTINUES* Survey and Map five of the Phase 1 Sewer Expansion Projects** As the first step in a multi-year planning and design effort, the Barnstable Department of Public Works has contracted with multiple land surveying firms to survey and map five of the Phase 1 Sewer Expansion Projects identified in the Town's Comprehensive Wastewater Management Plan. The projects include the mapping of dozens of roadways, including many residential areas for the following Phase 1 projects:

- Phinney's Lane Sewer Expansion Project which includes Phinney's Lane from Route 132 to Route 28 including residential roads to the east and west of Phinney's Lane
- Long Pond Area Sewer Expansion Project which includes all roadways between Old Stage Road /Park Avenue (western limits) and Strawberry Hill Road (eastern limits) and including the residential areas on the north and south side of Pine Street
- Route 28 East Sewer Expansion Project which includes Route 28 from the Water Pollution Control Facility property to Phinney's Lane
- Route 28 Centerville Sewer Expansion Project which includes Route 28 from Phinney's Lane to East Osterville Road and includes East Osterville Road and Old East Osterville Road
- Route 28 Marstons Mills Sewer Expansion Project which includes Route 28 from East Osterville Road to Old Post Road

Citizens can expect survey field crews to be working within the project areas at various times throughout the summer and fall. In the coming weeks, property owners within the project areas will be receiving notifications from the survey consultants which provide further detail on the survey project. Extra steps to prepare for hurricane season during COVID-19

Include face coverings, disinfectants & hand sanitizer in emergency kits
Sheltering at a hotel or relative's house may be safer than a large shelter, especially if you are in a high risk population
