#### Groundbreaking to Mark Major Milestone of the Town's CWMP

Joined by Congressman William Keating, Sen. Julian Cyr, Rep. Kip Diggs, Rep. Steven Xiarhos, MassDEP Deputy Commissioner Gary Moran, Cape Cod Commission Executive Director Kristy Senatori, Town Council President Matthew Levesque, Town Council Vice President Paula Schnepp, Town Councilors Nikolas Atsalis, Kris Clark, Paul Hebert, Paul Neary, Tracy Shaughnessy, Eric Steinhilber, Town Manager Mark Ells and DPW Director Dan Santos, the Town of Barnstable held a groundbreaking event to mark a major milestone in the Town's efforts to protect the heath of coastal waters, ponds and drinking water. The Strawberry Hill Road Sewer Expansion Project, set to begin construction next week, is the first major sewer expansion project in Phase 1 of the Town of Barnstable's Comprehensive Wastewater Management Plan (CWMP). The Strawberry Hill Road project will provide sewer service to approximately 300 properties in the village of Centerville.

Project construction is being coordinated with Vineyard Wind, to minimize cost and construction-related disruption to residents and businesses. The sewer expansion called for in the CWMP will fully address nitrogen pollution that currently threatens the health of coastal water resources. The CWMP calls for expanding sewer service to 11,800 properties in the Town in three phases over thirty years. Phase 1 accomplishes 40% of that goal in this decade.

#### **Barnstable Harbor Shellfishing Closure Lifted**

As of sunrise on Wednesday September 15, 2021, the closure from Ida in Barnstable Harbor is lifted.

#### Town Council Meeting – Thursday, September 16, 2021

The <u>September 16, 2021 Meeting of the Barnstable Town Council</u> was conducted remotely and physically closed to the public. Alternative public access was provided through Zoom. Town Council President Matthew Levesque opened the meeting by inviting Town Councilor David Bogan to lead the <u>Pledge of Allegiance</u>. President Levesque offered the <u>Moment of Silence</u>. Next up was <u>Public Comment</u> and <u>Council Response to</u> <u>Public Comment</u>. Town Manager Mark Ells presented his <u>Town Manager Communications</u> for period September 3-16, 2021:

- We are proceeding with the budget action calendar for FY 2023. As stated at prior Town Manager communications we have expanded the action items in the budget calendar to recognize the meetings of the School Committee as they develop the FY 2023 proposed operating budget. As noted in the Budget Action Calendar with a joint meeting of Town Council and School Committee scheduled for October 21, 2021. For information on our fiscal year budgets please view the Town's Open Budget website at http://budget.townofbarnstable.us.
- 2. We began removal of the barriers on Main Street Hyannis last night and plan to complete the removal this evening. The results of the survey and polls taken during our summer season regarding Main Street Hyannis are available on the <u>Planning & Development website under Current Projects Main Street 2021</u>.
- 3. Cape Cod Gateway Airport will conduct an in depth exercise involving safety protocols via a full-scale emergency drill on Tuesday, September 28 at 5:00 PM at the airport grounds in Hyannis. The exercise will simulate a completely mock scenario of an aircraft accident. While the drill takes place, please be advised that there will be active police, fire and helicopter activity in the vicinity of the Airport. The Airport will remain open to scheduled and charter operations during this exercise. For further drill information, please contact the airport manager's office at 508-775-2020 or kservis@flyhya.com.
- 4. On September 15, 2021 the Secretary of Housing and Economic Development Michael Kennealy visited Barnstable for a round table discussion regarding use of the state's ARPA Funds. The administration is hopeful that the funds will be distributed to communities in the near future We will continue to work closely with the Secretary and the Administration to secure funding when it does become available.
- 5. On Thursday, September 9, 2021, Town Engineer Griffin Beaudoin attended the Seaport Economic Council meeting where the Town of Barnstable was awarded two grants totaling \$722,400 for engineering and permitting associated with proposed improvements of Hyannis Harbor. The first grant received was a Seaport Economic Council Infrastructure Grant in the amount of \$465,600 for engineering and permitting of the Bismore Park Marina Improvements Project, which will include reconstruction of the Bismore Park Marina bulkhead and adjacent docks/slips. The second grant received was a Seaport Economic Council Dredging Grant in the amount of \$256,800 for the engineering and permitting of the Hyannis Inner Harbor. Engineering and permitting of these projects is anticipated to take approximately 18 to 24 months, with construction targeted in 2024. We will keep you advised of our progress on this project.

- 6. We continue to have regular conversations with Vineyard Wind (VW) regarding the status of the Phase I and Phase II VW Projects. VW continues to work with Barnstable staff regarding both Phase I & II of the project. They have commenced construction on Phase I and are proceeding with permitting on Phase II. We have continued our discussion with Vineyard Wind regarding an update to the existing Host Community Agreement (HCA) for Phase II and a potential Phase III. There is a resolve before Town Council this evening authorizing the Town Manager to modify the existing HCA to reflect the modification of the Phase II project. We will continue negotiation with VW as previously authorized in 2019 on a Phase III project including a discussion of the proposed landing and cable routing. We will keep you advised of our progress on this matter.
- 7. The Town of Barnstable's Department of Public Works announced that sewer construction for the Strawberry Hill Road Sewer Expansion Project will commence on September 20<sup>th</sup>. A Groundbreaking ceremony has been scheduled for Friday September 17, 2021 at 11:00 AM. The new gravity sewer will be installed in portions of Craigville Beach Road, Strawberry Hill Road, Wequaquet Lane and Phinney's Lane. Additionally, a new submersible pump station will be installed on a Town easement at the intersection of Strawberry Hill Road and Craigville Beach Road. Construction will be coordinated with Vineyard Wind, which will be installing a duct bank and associated utility relocations in the same area as part of its offshore wind energy project. Upon the completion of both projects, Vineyard Wind will resurface disturbed roadways within the project area. Joint Meeting with the Board of Health and Workshop on Managing Sewer Expansion in the Town. OLD BUSINESS began with Continuing Agenda Item 2022-007, as written, Amending the Code of the Town of Barnstable, Part I General Ordinances, Chapter 240 Zoning by adding a Mixed-Use Sub Zone of the Medical Services Overlay District to a public hearing to be held at the Town Council meeting on October 21, 2021, subject to an affirmative majority vote of the Council. NEW BUSINESS began with Barnstable Police Chief Matthew Sonnabend presenting three Agenda Items 2022-017 Acceptance of the Mutual Agreement Document (MAD) for the donation of the Graykey Software and Hardware valued at \$25,270.50 from Operation Underground Railroad (O.U.R.); 2022-018 Acceptance of a Fiscal Year 2022 State 911 Department Training Grant in the amount of \$22,742.60 from the Commonwealth of Massachusetts, Executive Office of Public Safety and Security; and 2022-019 Acceptance of a Fiscal Year 2022 911 Support and Incentive Grant in the amount of \$270,026 from the Commonwealth of Massachusetts, Executive Office of Public Safety and Security which were approved. Finance Director Mark Milne presented Agenda Item 2022-020 Resolve approving the appointment of R. Lane Partridge as the Director of Assessing for the Town of Barnstable which was approved. The Town Council welcomed Mr. Partridge to the Town. Town Attorney Karen Nober presented Agenda Item 2022-021 Determination Under Section 19 of G.L. c. 268A, the Conflict of Interest Law which was approved. 

## Model School Resource Officer MOU Commission Public Input Sought

The Department of Elementary and Secondary Education (DESE) in partnership with Executive Office of Public Safety and Security (EOPSS) are co-chairing the <u>School Resource Officer (SRO) Memorandum Of Understanding</u> (<u>MOU) Commission</u>. The Commission is tasked with updating its <u>2018 model MOU</u> to be used as a template for local communities to adapt to meet their needs. This Commission is seeking public input on the types of information that should be included in the MOU. Please take approximately ten (10) minutes to <u>complete the survey</u> to help the Commission hear public feedback. Survey participants are encouraged to respond to all questions; however all are optional if there is a preference not to respond to a specific question. <u>Public comments</u> can be submitted in addition to survey responses, and will also help inform the Commission in the development of the MOU. All feedback is voluntary and anonymous.

#### **Oral Rabies Vaccine Baits Distribution Continues**

Beginning next week, oral rabies vaccine (ORV) baits for wildlife will be distributed throughout southern Plymouth County and Mainland Barnstable County. Once that has been completed, operations will be shifted to the Upper-, Mid-, and Lower-Cape in efforts to prevent the spread of terrestrial rabies across the Cape once again. On the map to the left, the orange area was treated with two black and red USDA helicopters. The exact



finish date is weather dependent. Due to areas of high human density, the portion noted in yellow will be treated by vehicles and foot beginning Friday, September 17th. Bait stations in selected areas will be filled this coming Monday as well. The ground-based distribution is expected to last between 1 and 2 weeks. During this time frame, you will see two low-flying helicopters, as well as several town, county, and federal vehicles, distributing baits. We ask that you keep your dogs on leash, obeying your town's leash laws. While the baits are generally safe for your pets, the fishmeal coating may cause your pet to experience an upset stomach. Additionally, every bait

that a dog consumes is one that is considered a lost dose that could have gone to an unvaccinated raccoon. This expanded campaign is in response to the first case of terrestrial rabies on the Cape in over 8 years. In May, a raccoon from Hyannis tested positive for the virus. ## Hyannis Open Streets Returns on Sunday, September 19th



It's time once again for a day of fun on Main Street, Hyannis. On Sunday, Sept. 19, from noon to 4 p.m., the village's central strand will be vehicle-free so all ages can stroll, cycle, or otherwise move through a multi-block outdoor festival. Hyannis Open Streets is back! The free event offers a wide selection of music – big band, the blues, and more – plus the ever-popular JT & Angel dance party. You can watch a demonstration of jujitsu or marvel at the skills of talented stilt walkers. Over on the Village Green, the ever-popular kids zone will feature a giant open-air slide, fun games, and – new this year – a kids karaoke on the bandstand stage. Many restaurants and stores along Main Street will be open Sunday, and some will have special offers reflecting the spirit of the day. Hyannis Open Streets is all about getting out and about. ## Full Scale Disaster Drill Thoroughly Tests Public Safety Procedures at Cape Cod Gateway Airport

#### Mock disaster event planned for September 28 calls for heavy public safety presence

Cape Cod Gateway Airport will conduct an in-depth exercise involving safety protocols via a full-scale emergency drill on Tuesday, September 28 at 5:00 p.m. at the airport grounds in Hyannis. The exercise will simulate a completely mock scenario of an aircraft accident. Actual aircraft will not be used in the drill, yet fire departments will be setting training fires and using other simulations to test the airport's emergency response plan. Police, Fire, Cape Cod and Falmouth hospitals, US Coast Guard, Federal Aviation Administration, Massachusetts Department of Transportation-Aeronautics Division, Airlines, American Red Cross, Emergency Management, and other Cape Cod towns will all play a role in the exercise. Training stations will be part of the drill allowing airport staff, fire departments, airlines, American Red Cross and others to respond to various simulations as part of the drill. This includes testing multiagency coordination and the workings of an incident command system; responding to live fires; answering the need of family and friends of victims involved in the mock aircraft accident; and simulating transport and medical care both onsite and at Cape Cod Hospital. Depending on COVID-19 restrictions, volunteers will also be on hand to play the roles of accident victims. "The Federal Aviation Administration requires us to stage a full scale drill every three years," said Airport Manager Katie Servis. "The ultimate goal of the exercise is to identify improvements to be made to our emergency response should a real disaster ever happen at the airport. Both strengths and weaknesses of the response will be noted and an evaluation team on hand to monitor and critique the exercise. The exercise tests multiagency coordination and response implementing use of the resources from its surrounding communities." "Full-scale exercises are important component in ensuring the safety of the traveling public. Exercises also provide an opportunity to test response plans that may be used during various types of emergencies, ensuring that the exercise has cross cutting value. We appreciate the efforts and assistance of all agencies involved," said Chief Peter Burke, Hyannis Fire. The Town of Barnstable Planning and Development Department is accepting proposals for the Community Development Block Grant (CDBG) program. CDBG is a federally funded program from the U.S. Department of Housing and Urban Development (HUD) that provides affordable housing, economic opportunities, and a suitable living environment to low and moderate-income residents.

## The Town is anticipating funds for the 2021 CDBG program year (7/1/2021 - 6/30/2022) in the amount of \$279,381.20 and \$181,767.44 in unexpended funds from the 2020 CDBG program year.

#### **Cyanobacteria Notice**



The Town continues cyanobacteria monitoring and reporting. Here are some tips to identify cyanobacteria blooms, what to do if you suspect a bloom, and who to contact.

#### Identifying Cyanobacteria Blooms

The Massachusetts Department of Public Health has provided examples of cyanobacteria blooms with scums and without scums. <u>https://www.mass.gov/service-details/identifying-cyanobacterial-blooms-and-scums-photographs-of-blooms-and-scums</u>

#### How do I know if there is a harmful algal bloom in the water?

Cyanobacteria can cause the water to appear slightly discolored, cloudy, or resemble pea soup or paint. They are usually blue or green but can also be brown or red. They can also give the water a bad odor. The cyanobacteria in some blooms are dispersed throughout the water, while in other blooms they are concentrated in a scum or mat, either on the surface of the water or in sediment along the shoreline.

#### What if you Suspect a Cyanobacteria Bloom? WHEN IN DOUBT, STAY OUT!

If you see a possible cyanobacteria bloom, avoid contact with the water. Contact the Health Department at 508-862-4644 or email <u>health@town.barnstable.ma.us</u>, if the bloom is at a recreational waterbody.

## Sign Up for Cyanobacteria Alerts

The Town of Barnstable contracted with the Association to Preserve Cape Cod (APCC) to conduct routine monitoring and reporting of Cyanobacteria in Barnstable's Lakes and Ponds. If you are interested in receiving an email notification, when a potentially toxic bloom is identified by APCC, you <u>must opt-in</u> to the APCC toxic alerts. ## Be Proactive Against Mosquitos in Your Backyard

Avoid mosquito bites by using EPA approved repellents, appropriate clothing and avoiding peak mosquito activity between dusk and dawn. Remove standing water by emptying containers and tarps. Check your risk levels throughout the season by visiting the State interactive website at:

As always please slow down and use extreme caution when traveling through the road construction areas and follow posted safety and detour signs.

#### \*NEW\* National Grid New Customer Hookups

Wednesday, September 22, 2021 Neuco crews will install new gas service on Cedar Street, Centerville and Cammett Road, Marstons Mills. Friday, September 24, 2021 Neuco crews will install new gas service on Lincoln Road, Hyannis. Typical natural gas service installation includes marking out underground utilities within the project area, excavation of the street, laying gas main, relaying customer's individual gas service and connecting those services to the main and installing meters. This project should take about two days to complete. Visit ngrid.com/service line to view a YouTube video explaining the replacement of the service pipe to customer homes. Operations will start promptly at 7:00 AM and run until 3:00 PM. Reduce speed, and use caution. All scheduled work is dependent on weather and/or may be impacted due to an emergency situation.

#### \*NEW\* Renovations to Oyster Harbor Bridge in Osterville

The Town of Barnstable's contractor, MAS Building and Bridge, Inc. (MAS), is under contract to complete a rehabilitation project to the Oyster Harbors Bridge. The project will involve repairs to an abutment joint, resurfacing of the entire asphalt deck surface, and replacement of the ship ladder. To complete the improvements, one-lane of traffic will need to be closed for the duration of the project. Temporary traffic signals will be installed to manage traffic during this time. MAS will begin mobilizing to the project site on September 20<sup>th</sup> at which time the lane closure will begin. The project is scheduled to be completed by December 3, 2021. The draw bridge will remain operational throughout construction, so there will be no impacts to marine navigation. Typical work hours will be impacted as a result of the lane closure and residents are encouraged to plan accordingly when traveling in this area. As always, please slow down and use extreme caution when traveling through or near construction areas, and follow posted safety signs.

#### \*NEW\* Drainage & Pavement Improvements on Goodview Way in Barnstable

Drainage and pavement improvements on Goodview Way in Barnstable are scheduled to begin during the week of September 20th, 2021. Work will include installation of new drainage system equipment, pulverizing and grading of the roadway sub-base, installation of new asphalt pavement and restoration of all disturbed areas. Please use caution and safe speeds when traveling on Wheeler Road during construction operations.

#### \*CONTINUES\* Bridge Barrier Replacement Project, Rt. 149 over Rt. 6 EB, WB

SPS New England Inc., acting through MassDOT, will be replacing the barriers at the existing Rt. 149 bridge that crosses over Rt. 6. The project includes the Installation of temporary construction signage, selective clearing and thinning, staged removal and replacement of bridge barrier and end posts, bridge pavement micromilling and Superpave Waterproofing Surface Course placement, pavement markings and incidental items necessary to complete the work. Weather pending, construction will be on-going, Monday through Friday from 7:00 AM to 3:30 PM until completion of the work. Work within Route 149 began September 13, 2021 and construction duration is anticipated to be 22-months. The construction will be staged with lane shifts, and two-way traffic will be maintained throughout construction. As always, please slow down and use extreme caution when traveling through the road construction areas, and follow posted safety and detour signs. \*UPDATED\* Drainage & Pavement Improvements on Wheeler Road in Marstons Mills Drainage and pavement improvements on Wheeler Road in Marstons Mills are currently on-going and will continue during the week of September 20th, 2021. The remaining work will include punch list items. Please use caution and safe speeds when traveling on Wheeler Road during construction operations.

#### \*UPDATED\* Town Wide Drainage Improvements

The Town's contractor, Tasco Construction, will continue drainage improvements along Hinckley Circle in Osterville the week of 9/20/21. The work includes installation of new drainage systems, repairs to existing drainage systems, adjustment of drainage structure castings, and restoration of any areas disturbed during construction. Normal work hours will be between 7:00 AM to 3:30 PM, Monday through Friday. Through traffic will be maintained throughout construction. Any lane closures will be supported with police details to direct traffic. Motorists are advised to seek alternate routes to avoid the construction work.

#### \*UPDATED\* Roadway Improvements on Winter Street in Hyannis

Curb, sidewalk, drainage and roadway pavement improvements on Winter Street are ongoing and will continue through mid-November, 2021. New granite curb and paved sidewalks will be installed on both sides of the street between North Street and Barnstable Road. Drainage improvements will also be made along with milling and paving of the roadway surface. Police details will be on site to direct traffic as needed. Please seek alternate routes to avoid delays during construction and use caution when traveling through work zones.

## \*UPDATED\* Roadway Improvements on Dunn's Pond Road in Hyannis and Oceanview Avenue & Poponessett Road in Cotuit

Roadway improvements will begin this week on the publicly-owned portions of Dunn's Pond Road in Hyannis and Oceanview Avenue and Poponessett Road in Cotuit. Dunn's Pond Road will receive full-depth reconstruction and a new pavement surface. Oceanview Avenue will be milled & overlaid with sidewalk modifications at the northern intersection with Main Street. Poponessett Road will be milled and overlaid east of Rushy Marsh Road with full-depth reconstruction and a new pavement surface on the section of the road west of Santuit Road. The work is expected to be complete in mid-November, 2021. Police details will be on site to direct traffic as needed. Please seek alternate routes to avoid delays during construction and use caution when traveling through the work zones.

## \*UPDATED\* Bumps River Bridge Repairs on South Main Street in Centerville/Main Street in Osterville

Work is scheduled during the week of September 13th, 2021. Normal work hours are 7:00 AM to 3:30 PM, Monday through Friday. Remaining work includes loaming and seeding shoulders, placing milling mulch under guardrails, and addressing other punch list items. The bridge will remain open to traffic during this work. There will be temporary single-lane closures with signs and police officers to direct traffic past the work zone.
