About the CIBC

- The Cape & Islands Bridges Coalition (CIBC) was formed in early 2024 under the leadership of the Cape Cod Chamber in response to business and community concerns
- The CIBC aims to ensure the Sagamore and Bourne Bridges are replaced in a timely and fiscally responsible manner while minimizing adverse impacts on Cape Cod's 230,000 yearround residents and 8,000+ businesses
- Comprised of representatives from nearly 50 major employers, civic groups, and professional organizations across Cape Cod, the Islands, South Shore, and Greater Boston
- Modeled after the Boston-based A Better City and their work on the Central Artery/Tunnel Project





CIBC Objectives

- Funding and a construction timeline for both bridges must be prioritized by the Commonwealth and USACE, and all options must be considered.
- 2. A mitigation plan must be developed for both bridges to minimize disruption
- 3. The public must be engaged as an informed partner in the mitigation of bridge construction impacts, maintaining open communication with the constructors, the Commonwealth, and USACE.
- 4. Plans must protect and enhance what already exists and demonstrate respect for past traditions of the Cape and Islands.

CIBC Timeline & Work to Date

- NOVEMBER 2023 Founding companies support formation of CIBC in the aftermath of 2023 bridge maintenance and impacts
- **DECEMBER 2023 MARCH 2024** Development of CIBC mission, vision, and structure, using A Better City as model. Recruitment begins. Cape Cod Chamber secures seat on Governor's Transportation Funding Task Force
- MARCH 2024 APRIL 2024 Founders hold state and federal delegation meetings
- MAY 2024 First quarterly meeting of the CIBC
- JUNE 2024 Founders and Chamber reps travel to Washington DC to meet in person with Massachusetts Congressional Delegation
- JULY 2024 Commonwealth awarded \$993M in federal funding for Sagamore Bridge

What is the public perception of the bridges replacement plan?


Bridges Public Opinion Poll

Poll showed 86% of residents on Cape Cod, Nantucket, and Martha's Vineyard support the current replacement plan, as presented by **MassDOT**

Broad and Strong Support for the Plan to Replace Both Bridges

Replacement of Both Bridges Initial Support

The Commonwealth of Massachusetts and the Army Corp of Engineers are working on a plan to replace the two bridges that connect Cape Cod to the mainland. The new bridges will each carry six lanes of traffic, with two lanes in each direction and a dedicated turn lane each way. The project will take about ten years to complete and cost an estimated four-point-five billion dollars. The Sagamore Bridge will be paid for with a combination of federal and state funding. Funding for the Bourne Bridge has not yet been identified.




Strongly oppose Somewhat Don't know/ Somewhat support Strongly support
