Partial Demolition. Move the front door and windows. Add a small porch with overhang.

Partial Demolition. Demolish the porch and rebuild it. Re-roof with red cedar shingles, windows to match existing, and reside with red cedar shingles.

Partial Demolition. Demolition to the side and rear of the cottage to accommodate new additions. Cottage renovation.

In an emergency, a public body shall post notice as soon as reasonably possible prior to such a meeting. Notice shall be printed in a legible, easily understandable format and shall contain: the date, time and place of such meeting and a listing of topics that the chair reasonably anticipates will be discussed at the meeting. For meetings of a local public body, notice shall be filed with the municipal clerk and posted in a manner conspicuously visible to the public at all hours in or on the municipal building in which the clerk's office is located.
